



# YieldMax™ Launches AMZY, the YieldMax™ AMZN Option Income Strategy ETF

(AMZN)**. AMZY is actively managed by ZEGA Financial. **The ETF does not invest directly in AMZN.**

AMZY is the latest member of the YieldMax™ ETF family and like all YieldMax™ ETFs, aims to deliver monthly income to investors. **AMZY** joins existing YieldMax™ ETFs, **TSLY, OARK, APLY** and **NVDY**, whose distribution and yield information are provided in the table below:
