These ETFs seek to generate monthly income via a synthetic covered call strategy on **Meta Platforms, Inc. (META)** and **Alphabet Inc. (GOOGL)**, respectively. Both ETFs are actively managed by ZEGA Financial. **The ETFs do not invest directly in META or GOOGL.**

FBY and GOOY are the latest members of the YieldMax™ ETF family and like all YieldMax™ ETFs, aim to deliver monthly income to investors. **FBY** and **GOOY** join existing YieldMax™ ETFs, **TSLY, OARK, APLY, NVDY** and **AMZY**, whose distribution and yield information is provided in the table below:
