

# **YieldMax™ Launches Option** YieldMax Income Strategy ETFs on Microsoft and Disney

MSFO and DISO seek to generate monthly income via a synthetic covered call strategy on Microsoft Corporation (MSFT) and The Walt Disney Company (DIS), respectively. The ETFs are actively managed by ZEGA Financial. These ETFs do not invest directly in MSFT or DIS.
